Council Meeting held on Wednesday 5th October 2011

The Minutes

The minutes of the Council and Management meeting on the 7th September 2011 were taken as read, approved as a true record, and signed

Matter arising

- a) Elland, Kirkheaton, and Thongsbridge are fined £5 each and Hoylandswaine are fined £10 (2nd non attendance) for their non- attendance at the September Council meeting in accordance with Rule L3(e).
- b) The President announced the nominations for the position of Chairman. They are Trevor Atkinson, Ron Tindall and Paul Whiteley. _He informed the clubs that voting papers would be sent out and the completed forms to be returned in a sealed envelope to the Administration Secretary, Judith France at 12a Kaye Lane, Almondbury, Huddersfield HD5 8XP before Monday 31st October 2011. The envelopes are to be opened by the President at the Executive Meeting on Wednesday 2nd November 2011.

The Marsden representative asked that if nominations had been received for a position on the Secretariat and the serving officer had not been nominated, could the serving officer still be classed as being a nominee. The Chairman said that according to Rule L3(b) if the serving officer had not been nominated by a club and there were no alternative nominations, then if he/she was willing to serve he/she could be re- elected, but not if there were other nominations.
