Financial Matters - AH

The League's Financial Statement of Accounts for the year to 31st Oct 2024, already distributed to Clubs with the meeting Agenda, were reviewed and approved.

They showed a small surplus of £901, following a loss in 2023. The improvement was mainly due to the attraction of a new sponsor – Walker Timber – and higher attendances at HCL's 2024 Finals.

At the year end reserves totalled just over £54k.

ECB Premier League - TA

As required by Paul Bedford of the ECB the following statement was read out at the meeting. The background to the statement and related matters were handled in the immediately following HCL Council Meeting.

Quote

As part of the ECB Accreditation Premier League requirements, clubs with a 1st XI in the Top 2 Divisions of the Huddersfield Cricket League are required to have at least 3 Junior hardball cricket teams. This requirement covers any age groups from the Under 11s and must include at least one Under 15 side. Failure to meet the above requirement may result in relegation or denial of promotion from the respective Division until the 'Junior Section' requirement has been met to the satisfaction of the Yorkshire Cricket Board and ECB.
