Matters Arising

Kirkburton Appeal – Sykes Cup R1 v Moorlands

The Chairman confirmed that HPCL Clubs of the Council voted to uphold Kirkburton's appeal. He reflected on the circumstances leading to the issue, noting the committee is currently overstretched and in need of more support.

Executive oversight and administration for the future

The Chairman reiterated the need for structural changes to the way the League is managed and administrated.

He said that discussions will take place with the General Secretary and Administration Secretary to map a better way forward.

The Media Secretary highlighted the need for a more structured media team, ideally consisting of a Media Secretary, Web Content Manager, and Social Media Lead.

Due to increased professional commitments, Jamie will step down after September.

ECB Premier League Accreditation – Girls Section Criteria - TA

The Chairman reported on discussions with Grace Pearce of the ECB, confirming that from the 2028 season, the top 24 clubs in each ECB Premier League must run a women's or girls' team. Currently, 15 out of 24 HPCL Clubs meet this criterion.

A communication received from the ECB regarding these matters has been shared with all member Clubs.

Financial Report - TA (on behalf of AH)

The Report confirmed that the finances of the League are in a satisfactory state, with an overall balance of just over £53k.

Shelley CC's sight screen loan has been paid to them.

Match & Registration Secretary Report - PS

Sykes Cup Semi-Finals

It was agreed not to charge gate fees at the semi-final matches due to minimal returns. Home clubs will pay umpires' fees.

Sykes Cup Final Venue

If Honley become a finalist then the venue for the Final will have to be changed. The General Secretary has reviewed and confirmed Thongsbridge CC as a suitable alternative venue, should that prove to be necessary.

Other Cup Final Arrangements

It was agreed that the host club for T20 Finals Day (2nd August) must provide a PA system or borrow the League's.

The General Secretary will contact clubs to confirm whether finalists in the Oddfellows and Earnshaw Cups will provide teas, once semi-finals are completed.

The June Fines List is attached to these Minutes. It was noted that on June 6th there were no offences and 2 umpires at every game.

Complaints by Denby (Umpires inadvertently allowing a bowler to exceed his T20 limit) and Almondbury (attempting to register a 2nd overseas player on day of game) were rejected.

Denby Grange (home to Cumberworth - no compensation) and Clayton West 2nd XI (away to Marsden - £100 compensation) have each conceded a game. They will each pay a £50 fine and will be penalised 2 points for a 1st offence.
